 elective public office".
 - ii. BrooklineCAN is a "project" under the Senior Center not a 501(c)(3) organization itself.
 - iii. Cannot campaign and lobby for politicians.
 - iv. Can advocate but limited as % of total budget (not an issue).
 - v. Purpose of BrooklineCAN is to advocate.
